### M.Phil. Regulations

(Rules & Regulations governing M.Phil. Programme of Shree Somnath Sanskrit University – Veraval as per the U.G.C.'s Minimum Standards and Procedures for Award of M.Phil. Degree Regulations 2009 notified vide **Gazette of India** No. 28 dated 11.07.2009 (*Ashadha 20, 1931*), amendments made as per the University Grants Commission Minimum Standards and Procedures for Award of Ph.D. Degree) Regulations, 2016 notified vide **Gazette of India** No. 278 dated 05.07.2016 (*Ashadha 14, 1938*) & pp. 4049-4056 and U.G.C.'s letter No.F.No.1-1 (2002) (PS) Pt file III, dated 20.08.2009 to amend the concerned regulations accordingly, further amendments made as per the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degrees) (1<sup>st</sup> Amendment) Regulations, 2018 notified vide **Gazette of India** No. 325 dated 27-08-2018 (*Bhadra 5, 1940*) & pp. 1-2 with U.G.C.'s letter No.F.No.1-1/2002 (PS) Exempt (Pt. #### M. Phil. Regulation No. 01

##### General

- 1.1 This Regulation shall come into force with effect from the date of its notification.
- 1.2 There shall be M.Phil. Entrance Test (known as MET) for admission in the M.Phil. Programme of the University every year. The Entrance Test shall be held in the beginning of an academic year by the University. The student who qualifies in this test will be eligible for admission to M.Phil. Programme of the University. The Combine Merit list for admission to M.Phil. Programme with the weightage of 50 Marks (50%) of MET and 50 Marks (50%) of Acharya/M.A./Post Graduate Degree result shall be in place.
- 1.3 M.Phil. Entrance Test (MET) Committee shall be constituted by the Vice-Chancellor. The Committee shall have one Chairperson, and five members. Mandate of the Entrance Test Committee shall be as follows:
  - (i) to scrutinise application forms
  - (ii) to conduct the M.Phil. Entrance Test (MET)
  - (iii) to prepare the result,
  - (iv) to submit the result of M.Phil. Entrance Test for declaration
  - (v) to announce time table for the Entrance Test
  - (vi) Any related work assigned by the Vice-Chancellor
- 1.4 The Registrar shall declare the combine merit list for admission to M.Phil. Programme with the weightage of 50 Marks (50%) of MET and 50 Marks (50%) of Acharya/M.A./Post Graduate Degree result through notification by keeping the reservation policy of the State/Central Government in consideration.
- 1.5 The number of seats available subject-wise shall be notified in an advertisement / on the University website as per UGC guidelines.
- 1.6 While admitting students to the M.Phil. Programme, the reservation policy of the State / Centre Government shall be followed by the University.
- 1.7 The M.Phil. Programme shall be of minimum **two (2)** semesters (i.e. 1 year) and maximum of **four (4)** semesters (i.e. 2 years) (Old: The M.Phil. Programme shall be of minimum **two (2)** semesters (i.e. 1 year) and maximum of **ten (10)** semesters (i.e. 5 years)
- 1.8 The Post Graduate Section of the University shall put up the file for all above processes.

#### M. Phil. Regulation No. 02

## **Eligibility, Admission Procedure and Allocation of Students**

- 2.1 A candidate intending to enrol himself/herself for the M.Phil. Degree must be a post graduate degree-holder with 55% or B+ and must have passed the M.Phil. Entrance Test (M.E.T.). Candidates belonging to SC/ST category shall be given relaxation of 5%. Relaxation of 5% marks shall also be given to physically challenged/disabled candidates.
- 2.2 Candidates appearing in the final examination of the Acharya/M.A./Post Graduate Degree shall also be eligible to apply for the M.Phil. Entrance Test but their Entrance Test result will be validated only after their final Post Graduate Degree Examination Result declaration/availability in the same **cycle-year** which shall not be later than the date of registration.
- 2.3 Allocation of research supervisor/guide to a candidate shall be decided by the University in a formal manner depending upon the number of students per faculty, available specialization among faculty supervisors, and the research interest of the student as indicated by the student in his/her application. The allocation of supervisor shall not be left to the individual student or teacher. For this purpose, the Post Graduate Section of the University shall put up the file every year separately.
- 2.4 The students who qualify UGC/CSIR (JRF) examination NET/SLET/GATE/Teacher Fellowship holders shall be exempted from the M.Phil. (M.E.T.) Entrance Test. However, they would be required to fill up the M.Phil. Entrance Test Form.
- 2.5 Provided that 20% seats of each subject shall be reserved for the above categories, however, other students may be considered if sufficient numbers of students belonging to above categories are not available.
- 2.6 Change in the Title of the dissertation of M.Phil. shall be possible with the approval of the Vice-Chancellor.
- 2.7 M.Phil. Candidates who are awarded any scholarship/fellowship/freeship by the U.G.C./State Government/Central Government/or any Governmental Body shall submit to the Registrar of this University his/her **Six Monthly Progress Report (Annexure-I)** at the end of every semester duly approved by his/her Supervisor/Guide and the Head, Post Graduate Section of this University.
- 2.8 M.Phil. Candidates who are awarded any scholarship/fellowship/freeship by the U.G.C./State Government/Central Government/or any Governmental Body shall submit to the Registrar of this University his/her **Quarterly (Three Monthly) Continuance Certificate (Annexure-II)** at the end of every three months duly approved by his/her Supervisor/Guide and the Head, Post Graduate Section of this University, for the further step of next instalment fellowship disbursement from the concerned body.
- 2.9 In case of relocation of an M. Phil. woman scholar due to marriage or otherwise, the research data shall be allowed to be transferred to the University to which the scholar intends to relocate provided all the other conditions in these regulations are followed in letter and spirit and the research work does not pertain to the project secured by the parent institution/ supervisor from any funding agency. The scholar will however give due credit to the parent guide and the institution for the part of research already done.

## **M. Phil. Regulation No. 03**

### **M.Phil. Entrance Test (MET)**

- 3.1 The Entrance Test shall have the syllabus/contents as per M.Phil. Regulation No. 18.
- 3.2 The nature of the Test shall be Multiple Choice Question (MCQ) type. There will be 50 Multiple Choice Questions (MCQs) of 50 Marks.
- 3.3 The following proviso shall be added to the clause 5.4.1 of the University Grants Commission (Minimum Standards and Procedure for award of M.Phil/Ph.D Degrees) Regulations, 2016 -  
“provided that a relaxation of 5 % of marks (from 50% to 45%) shall be allowed for the candidates

*belonging to SC/ST/OBC(Non-Creamy layers)/Differently-abled category in the entrance examination conducted by the Universities. Provided further that, if in spite of the above relaxation, the seats allotted for SC/ST/OBC(Non Creamy layer)/Differently-abled categories remain unfilled, the concerned Universities shall launch a Special Admission Drive, for that particular category within one month from the date of closure of admissions of General Category. The concerned University will devise its own admission procedure, along with eligibility conditions to ensure that most of the seats under these categories are filled.”*

- 3.4 Registration of M.Phil. Entrance Test (MET) Fee will be Rs.200/- (Two Hundred Rs. Only) from the academic year 2020-21 onwards.
- 3.5 M.Phil. Entrance Test (MET) Application Form will be in place from the academic year 2020-21.
- 3.6 The qualifying criteria for admission to M.Phil. Programme will be 50% for General/Open Category and 45% for Reserved Category (*as indicated above in 3.3*) of the Combine Merit list with the weightage of 50 Marks (50%) of MET and 50 Marks (50%) of Acharya/M.A./Post Graduate Degree result.

### **M. Phil. Regulation No. 04**

#### **Change of Supervisor**

Only under special circumstances, the candidate may be allowed to change the supervisor by the Vice-Chancellor on the recommendation of the Dean of the concerned Faculty.

### **M. Phil. Regulation No. 05**

#### **Eligibility for M.Phil. Guideship/ Research Supervisorship:**

- 5.1 The prospective regular teachers of the University/affiliated Mahavidyalayas/Colleges/Research Centres only shall be eligible for Recognition as M.Phil. Guides. The candidate for the Guideship shall be eligible for recognition as M.Phil. Guides as per the following requirements:

(a) he/she is a P.G. recognised teacher of the University with a Ph.D. Degree.

(b) No teaching/research experience for the teachers of the P.G. Level after PG Recognition recruited through direct recruitment. Two years of teaching/research experience for the teachers of the U.G. Level. (Old: he/she has at least two years of teaching/research experience at the P.G. Level after PG Recognition or three years of U.G. experience.)

[Note: One who is directly recruited in this University through a duly constituted Selection Committee shall be deemed to be a recognized Post Graduate Teacher],

- 5.2 The number of seats for M.Phil. shall be decided well in advance and notified on the University website or in the advertisement.
- 5.3 E.C./A.C. of the University, at any time on the recommendation of the Research Section, shall be empowered to withdraw the Guideship of a recognised teacher. The Research Section can make such a recommendation on the ground of: (a) moral turpitude, and / or (b) plagiarism, and / or (c) any act harming the interest of the University.
- 5.4 A recognized Guide shall not be allowed to register a candidate for M.Phil. if the researcher is blood related/closely related to him/her.
- 5.5 The maximum number of candidates to be enrolled for M.Phil. Programme under the supervising teachers at a given point of time for different cadres shall be as follows:

Professor	: 03 students
Reader/Associate Professor	: 02 students
Lecturer/Assistant Professor	: 01 students

\*However, for the Principals who are recognized guides working in the scale of Professor shall be able to enrol three (03) students and those Principals who are recognized guides working in the

UGC pay scale of Assistant Professor (15,600-39,100 with AGP/GP of Rs. 6,000 /- & above from time to time) shall be able to enrol one (01) student.

(Old: The maximum number of candidates to be enrolled for M.Phil. programme under the supervising teachers at a given point of time for different cadres shall be as follows:

Professor	: 05 students
Reader/Associate Professor	: 04 students
Lecturer/Assistant Professor	: 03 students

\*However, for the Principals who are recognized guides working in the scale of Professor shall be able to enrol five (05) students and those Principals who are recognized guides working in the UGC pay scale of Assistant Professor (15,600-39,100 with AGP/GP of Rs. 6,000 /- & above from time to time) shall be able to enrol three (03) students.)

5.6 Teachers (who are research supervisors/guides) of the University/affiliated Mahavidyalayas/ Colleges/Research Centres shall submit the **M.Phil. Guide's Undertaking (Annexure-III)** to the University that they are/will no longer remain research supervisors/guides of any other University/Institution of India or abroad than this University as per the UGC's regulations 2009.

5.7 In the light of the UGC's letter no. D.O. No. F. 10-6/2011 (PS) Misc. dated 06-07-2015 and subsequent letter no. D.O. No. F. 10-6/2011 (PS) Misc. dated 04-09-2015 as well as in the light of the Higher Education Commissioner's Office letter no. CHE/ISC-7/यु.न./२०१५/११७८३-११८०४ dated 24-09-2015 and subsequent letter no. ISC-7-U.G.C.-2016-1126-2286 dated 05-01-2016; the following regulation shall remain abiding to the Research Supervisors/Guides:

*"Universities shall allocate the supervisor from amongst the **regular** faculty members (not Adjunct Faculty) in a department or its affiliated PG Colleges/Institutes depending on the number of students per faculty member, the available specialization among the faculty supervisors and the research interest of the student. It is further clarified that any Ph.D./M.Phil. Degree awarded by a University under the supervision of a supervisor who is not a faculty member of the University or its affiliated PG Colleges/Institutes would be in violation of UGC (Minimum Standards and Procedures for Award of M.Phil./Ph.D.) Regulations, 2009."*

## **M. Phil. Regulation No. 06**

### **Duration, Submission, Evaluation and Assessment Methods for M.Phil. Dissertation:**

6.1 The maximum time limit for submission of final M.Phil. Dissertation shall be four (04) semesters (i.e. 2 years) from the date of enrolment. In no way, University shall make any correspondence pertaining to the payment of semester fees to any M.Phil. Candidate nor shall the University remind the same.

(Old: The maximum time limit for submission of final M.Phil. Dissertation shall be ten (10) semesters (i.e. 5 years) from the date of enrolment. In no way, University shall make any correspondence pertaining to the payment of semester fees to any M.Phil. Candidate nor shall the University remind the same.)

6.2 The candidate shall submit the dissertation in **three (3)** copies and **three (3)** CDs in PDF format (with all files saved separately) along with the five (5) copies of the summary (abstract) of the dissertation separately written in about 600 words describing the salient features of his/her investigation. M.Phil. Candidate is advised to write his/her name, title of dissertation and registration number with date on CD. The dissertation submission will be made with the prescribed **M.Phil. Dissertation Submission Form (Annexure-IV)** that contains "No Dues Certificate" from the University Library/Department Library, P. G. Section, Hostel Administration, Canteen Administration.



- 6.3 In a case, if M.Phil. Candidate does not submit his/her M.Phil. Dissertation within four (4) semesters/two years from the date of enrolment, his/her enrolment shall stand automatically cancelled. No correspondence shall be made in this matter nor entertained by this University.
- 6.4 The dissertation, produced by the M.Phil. Student and submitted to the University, shall be evaluated by one examiner/referee. The examiner/referee shall be either from the University campus or from other Colleges/Universities of Gujarat.
- 6.5 Each candidate shall state with certificate by the supervisor that the work is based on the discovery of new facts by the candidate or of new relations of facts observed by others and that the work contributes to the general advancement of knowledge and it is his/her original research work.
- 6.6 In cases where in, the M.Phil. Candidate has completed his/her studies and meanwhile his/her recognized teacher who leaves the University or is unavailable for this purpose, another guide/supervisor shall be appointed for this purpose by the Vice-Chancellor. If such an appointment is not possible, then candidate shall be at liberty to submit his/her dissertation independently.
- 6.7 Every dissertation shall be examined by one examiner/referee. The examiner/referee shall be appointed in the manner indicated below:
- (a) The concerned Faculty Dean shall suggest to the Research Section a panel of three (3) examiners/referees in a given format. However, the examiners/referees should be the Ph.D. degree holder and recognized research supervisor/guide of the concerned University/Institution. The Vice-Chancellor shall select one name of the examiner/referee from the panel submitted to him on file by the concerned Faculty Dean. M.Phil. dissertation/s shall go for evaluation within a week from the office.
- 6.8 The examiner/referee shall submit his/her **M.Phil. Dissertation Evaluation Marks/Report** in a given format along with the dissertation. M.Phil. Dissertation Evaluation will be of maximum 80 Marks and the Viva-Voce Examination will be of maximum 20 Marks. The combination of both shall be of maximum 100 Marks (80+20). The passing marks shall be as per the University rules and regulations.
- 6.9 On receipt of the passing marks from the examiner/referee, the M.Phil. candidate shall undergo a Viva-Voce Examination. One subject expert and concerned guide/ research supervisor shall conduct the Viva-Voce Examination. The mode of the Viva-Voce Examination shall be both Online and In Campus as per the UGC guidelines for M.Phil. candidates. The University shall inform the research supervisor/guide of the passing / failing result of his/her research student. On receipt of the news of passing result from the University, the research supervisor/guide shall write to the University seeking permission to conduct the Viva-Voce Examination of his/her research student as per **Permission Form for Viva-Voce Examination (M.Phil.) (Annexure-V)**.
- 6.10 Prior to the award of M.Phil. Degree, the University shall issue M.Phil. Notification bearing notification no. stating the fact to the effect that the M.Phil. Degree has been awarded in accordance with the provisions of the UGC's Minimum Standards and Procedures for award of M.Phil. Degree Regulations - 2009 at the end of every quarter (every three months).
- 6.11 The women candidates and Persons with Disability (more than 40% disability) may be allowed a relaxation of one year for M.Phil. In addition, the women candidates may be provided Maternity Leave/ Child Care Leave once in the entire duration of M.Phil. for up to 240 days.
- 6.12 31<sup>st</sup> July will be the last date for submission of M.Phil. Dissertation every year.

### **M. Phil. Regulation No. 07**

A candidate shall not be permitted to submit a dissertation for which a Degree has been already conferred in this or in any other University.

### **M. Phil. Regulation No. 08**

For specialized and technical subjects, if there is an eminent scholar working in a Research Institute, he/she may be recognized by the Vice-Chancellor in the same and interdisciplinary subject as an M.Phil. supervisor/guide.

### **M. Phil. Regulation No. 09**

M.Phil. dissertation that has been failed/rejected earlier may be resubmitted after revision, subject to the payment of one semester fee. A dissertation required to be revised should be resubmitted within not more than twelve (12) months, failing in which the candidate shall be required to go in for re-enrolment. The revised dissertation shall be sent to the same referee. However, in the event of refusal by the original referee, another referee shall be appointed.

### **M. Phil. Regulation No. 10**

#### **Limit on Number of Research Students for Guidance**

A Research Supervisor/Guide for M.Phil. Degree shall not at any one time guide more than three (3) M.Phil. students or the limits stipulated in M.Phil. Regulation No. 5.5 above. Provided that the number of candidates registered with the co-supervisor shall not be counted for the number of candidates under a supervisor. Provided further that a person shall not be allowed to supervise more than five students at a given point of time although he/she is registered in more than one subject/discipline.

### **M. Phil. Regulation No. 11**

#### **Submission of M.Phil. Dissertation to UGC**

Following the successful completion of the evaluation process and announcement of the award of M.Phil. Degree, the University shall submit a soft copy of the M.Phil. Dissertation to U.G.C. within a period of thirty days, for hosting the same in IFLIBNET, accessible to all Institutions/Universities. The University may also display the thesis on its website.

### **M. Phil. Regulation No. 12**

#### **Definitions**

- 12.1 **University** means Shree Somnath Sanskrit University - Veraval.
- 12.2 **M.Phil. Candidate** means a candidate, who has obtained a Master Degree in any discipline of Sanskrit and has submitted his candidature for the purpose to enrol and pursue Master of Philosophy (M.Phil.) study.
- 12.3 **Enrolment** means enrolment of a research scholar with the purpose to conduct research study for the M.Phil. Degree programme after fulfilment of relevant statutory requisites.
- 12.4 **M.Phil. Regulations** means the rules & regulations governing M.Phil. Programme of Shree Somnath Sanskrit University.
- 12.5 **Tattvacharya / M.Phil. Degree** means the degree of Master of Philosophy in English and *Tattvacharya* in Sanskrit as provided under the Act No. 25 of 2005 of Shree Somnath Sanskrit University - Veraval. The first one is abbreviated as M.Phil.
- 12.6 **Research Supervisor / Research Guide** means a M.Phil. Supervisor who supervises or guides M. Phil. scholars.
- 12.7 **M.Phil. Dissertation** means minor research on specific area or the subject of specialization.

### **M. Phil. Regulation No. 13**

Fee structure decided by the University and any changes in fee structure from time to time shall be applicable. With effect of these amended regulations, previous M.Phil. regulations stand repealed.

## **M. Phil. Regulation No. 14**

### **M.Phil. Fellowships**

- 14.1 Candidates who are receiving any assistantship/scholarship/fellowship/freeship from the U.G.C./State Government/Central Government/or any Governmental Body/ any other agency/projects shall be Regular (Full Time) Candidates of the University.
- 14.2 A full time M.Phil. Candidate shall be present in the University for a minimum of 75% working days and other course requirements.
- 14.3 A full time M.Phil. Candidate shall be eligible for 12 days of casual leave and 30 days of medical leave per year recommended by the registered medical practitioner not below the rank of a civil surgeon.
- 14.4 For UGC-JRFs/SRFs/other fellowship holders, the rules framed by the UGC will be applicable in the matter of leave, attendance, drawing of scholarship, contingency grants, travelling for research work etc.
- 14.5 M.Phil. Candidates who are awarded any assistantship/scholarship/fellowship/freeship from the U.G.C./State Government/Central Government/or any Governmental Body/ any other agency/projects shall join the University/Institution by filling up the **Joining Report (M.Phil.) (Annexure - VI)** in the prescribed format of the University.
- 14.6 University rules, regulations and timings will be applicable to the Regular (Full Time) M.Phil. Candidates who are receiving any assistantship/scholarship/fellowship/freeship from the U.G.C./State Government/Central Government/or any Governmental Body/ any other agency/projects.

## **M. Phil. Regulation No. 15**

### **Publication of M.Phil. Dissertation**

- 15.1 After the award of M.Phil. Degree, the entire dissertation or any part of the dissertation may be published by the candidate on his/her own account with the written permission of the University, giving due credit to the Research Supervisor. He can seek the permission by submitting an application to the University. If any M.Phil. candidate wants to translate it into any vernacular language/English and then publish it on his/her own account, the Vice-Chancellor may permit him/her to do so after taking into consideration remarks, if any, in the matter of publication of the dissertation in the reports of the referees concerned. M.Phil. candidate shall write to the University seeking permission for publication of his/her M.Phil. Dissertation as per **Permission Form for Publication of M.Phil. Dissertation (Annexure-VII)**. While granting such permission, following conditions may be prescribed.
- 15.2 The dissertation shall be published only with the permission of the University and such publication shall state on the title page itself that this was approved for the award of the M.Phil./Tattvacharya Degree of this University.
- 15.3 Two complimentary copies of the published work are to be sent to the University Library immediately after publication is out in the market.

## **M. Phil. Regulation No. 16**

### **Withdrawal of M.Phil. Degree**

If M.Phil. Dissertation is proved to be a copy/plagiarism/academic misrepresentation/on detection of any irregularity, the University has powers to rescind the Degree even after the award of M.Phil. Degree and the University shall take suitable steps to withdraw the degree.

### **Promotion of Academic Integrity and Prevention of Plagiarism**
