Minutes of 16th Meeting of Publication Committee held on 29-08-2020

The 16th meeting of the Publication Committee of Shree Somnath Sanskrit University, Veraval was held on 29-08-2020 at 4:00 pm through ONLINE WEBEX MEET mode.

First of all, the Chairperson extended a warm welcome to all the members of the Publication Committee of Shree Somnath Sanskrit University, Veraval. The works done in accordance with the recommendations made in the previous meeting were ratified/ approved. Thereafter, the following matters were transacted.

1. The Publication Committee ratified/approved all the works done by the Publication Section as recommended from Sr. No. 1 to 12 in the meeting of 07-03-2020. All the works done by the Publication Section and mentioned in the Agendas of today's meeting from Sr. No. 1 to 13 are noted.
2. The Publication Committee recommends the publication of शास्त्रपरिचायिका in 500 copies with Maximum Retail Price (MRP) at the actual printing cost only. It is meant for the students of the University. So it will be sold with no profit and no loss agenda. It will be published from the private fund of the University. The University shall supply Complimentary Copies of it to all the Principals (each one) of the University affiliated Mahavidyalayas / Colleges free of cost. Further, all the teaching/academic staff of the University shall also be given Complimentary Copies of it (each one) at free of cost.
3. The Publication Committee recommends the modification in the Publication Regulations as per the noting pages of the concerned file of शोधज्योतिः. Further, the Committee recommends that the subject expert/s/reviewer/s shall be given maximum period of three (3) months to submit their review report/s with maximum three (3) reminders, if required. On non receipt of the review report/s from the respective subject expert/s/reviewer/s, the *Research Officer* shall put up the file after three months. With the permission of the Vice-Chancellor of the University on its concerned file, the *Research Officer* shall send the selected manuscript/book/Ph.D. Thesis/Title to the third/fourth subject expert/reviewer, whose name is given in a penal by the Publication Committee in waiting. The Publication Committee shall suggest a panel of two names of subject expert/s/reviewer/s with two additional names in waiting.
4. The Publication Committee recommends the publication of the University Diary-Calendar-Planner-2021 at the following approved tender rates.

5. The Publication Committee recommends the reprint of the book सुभाषितशतकम् of Dr. Narendrakumar L. Pandya from the University itself. सुभाषितशतकम् has been published by the University previously. It contains 102 verses in Sanskrit with Gujarati translation. Now, the reprint version of सुभाषितशतकम् contains the same 102 verses in Sanskrit with Gujarati translation. Hindi and English translations of these 102 verses have been added. Therefore, the Committee recommends not sending the book सुभाषितशतकम् of Dr. Narendrakumar L. Pandya for review, as it has been already reviewed and published by this University previously.

7. The Publication Committee recommends not to review the book *Śakti-mīmāṃsā in the Sanskrit Scriptures* of Dr. Chaman Lal Raina in this Financial Year of 2020-21 and to consider the same in the future course of time.
8. The Publication Committee recommends that the printing of the joint publication of Volume – 3 of वैयाकरणसिद्धान्तभूषणम् under MoU with FIP and EFEO, Pondicherry be made from the Aurobindo Press, Pondicherry in the Financial Year 2020-21.
9. The Publication Committee recommends not to review the Ph.D. Thesis of Dr. Khagendra Patra viz. The Gourakṣṇodayam (गौरकृष्णोदयम्) of Govinda Miśra in this Financial Year of 2020-21 and to consider the same in the future course of time.
10. Hon'ble Vice-Chancellor Prof. Gopabandhu Mishra Sir suggested the insertion of E-Publication/E-Publishing of the University publications in future course of time. Further, he suggested that E-Publication/E-Publishing of the University publications will save money and space of the University. He informed the Committee members that this matter will be put up before the members of the *Academic Council* and *Executive Council* for the detailed discussion and the necessary steps shall be taken in this regard. All the members of the Publication Committee agreed with the suggestion of our Hon'ble Vice-Chancellor Prof. Gopabandhu Mishra Sir and solemnly recommended the same for its further proceeding.

The meeting concluded with a vote of thanks to all the members present by the Member Secretary i.e. Research Officer.
