Publication Agreement for E-Book in PDF

Memorandum of Agreement

made between

A/E/R/T
(NAME IN CAPITAL) [Hereinafter termed as the **A/E/R/T** means **AUTHOR/EDITOR/RESEARCHER/TRANSLATOR**] on one part and

PUBLISHER: SHREE SOMNATH SANSKRIT UNIVERSITY,
Rajendra Bhuvan Road, Veraval,
Dist:-Gir Somnath, Gujarat-362266 (India)
[Hereinafter termed as the **PUBLISHER**] on the other part.

Whereas the **A/E/R/T** having written/compiled and edited a book provisionally titled as
.....
[Hereinafter termed as the **WORK**] desires to get it published from the **PUBLISHER**. It is hereby agreed to, by and between the parties hereto as follows:

1. The **A/E/R/T** shall deliver to the **PUBLISHER** the complete manuscript of the **WORK** including all other subsidiary materials like illustrations, photographs, drawings, maps, charts etc. on or before the publication.
2. The **A/E/R/T** guarantees the **PUBLISHER**, the **WORK** is in no way whatever a violation of any existing copyright, that it contains nothing of a libellous, seditious or scandalous nature and that he holds an intellectual copyright in the **WORK** and has full power to make this Agreement. The **A/E/R/T** shall indemnify the **PUBLISHER** from and against all proceedings and expenses, claims and demands that may be taken or made on the ground that the **WORK** is found to be a violation or an infringement of copyright or that it contains any pirated, libellous or scandalous of other unlawful matter.
3. In consideration of the payments hereinafter mentioned, the **A/E/R/T**, hereby, assign the **PUBLISHER**, during the legal term of unrestricted copyright, the exclusive right to publish the present and subsequent editions of the **WORK**. The **PUBLISHER** shall have the sole control on the manuscript along with its subsidiary materials, style, production, print order, publications, publicity and promotion, price sale, and terms of sale etc. The **A/E/R/T** shall not publish or cause to be published anywhere any abridgment, portion, translation of the **WORK** or any portion thereof, or any other **WORK** of a similar nature which may affect the sale of the **WORK**, without the written consent of the **PUBLISHER**.
4. The **PUBLISHER** shall also have the right to publish on terms of this Agreement, abridgement, adaptations or translations of the **WORK**, in any language by paying an honorarium payable to the translator(s) or adapter(s) without any approval of the **A/E/R/Ts/Editors/Institute**.
5. The **PUBLISHER** shall print 350 copies initially.

6. The **PUBLISHER** shall not be held responsible for accidental loss or damage by fire or otherwise to the manuscript along with the subsidiary materials of the **WORK** while it is in their custody or in the course of production. The **A/E/R/T** may keep additional copies of the manuscript along with its subsidiary materials. The **PUBLISHER** shall reserve the right to exercise the option of destroying the manuscript along with its subsidiary materials after three months of the publication of the **WORK** without any reference to the **A/E/R/T** for concurrence.
7. In case of Ph.D. Thesis being published in a book form under the series of **Research Grantha Series / संशोधन :थमाला** of this University, any kind of remuneration/honourarium shall **NOT BE PAID** to the RESEARCHER. (Neither Researcher's nor Soft Copy Development Remuneration/Honourarium)
8. The **AUTHOR** is to be paid Rs. 150 /- per page (A4 size with single line spacing and fonts size 12 for English, 14 for Sanskrit, Gujarati & Hindi with 2.5 cms margins from all four sides) of original writing. The **TRANSLATOR** is to be paid Rs. 100 /- per page (A4 size with single line spacing and fonts size 12 for English, 14 for Sanskrit, Gujarati & Hindi with 2.5 cms margins from all four sides). If any **AUTHOR** gives press ready soft copy in printing software (i.e. Corel file or Page maker file) with all proofs, then the **AUTHOR** is to be paid Rs. 50 /- per page (A4 size with single line spacing and fonts size 12 for English, 14 for Sanskrit, Gujarati & Hindi with 2.5 cms margins from all four sides) as soft copy development charge for running matter and the **AUTHOR** is to be paid Rs. 60 /- per page (A4 size with single line spacing and fonts size 12 for English, 14 for Sanskrit, Gujarati & Hindi with 2.5 cms margins from all four sides) as soft copy development charge for matter with formula/diagrams or multi lingual matter. No any remuneration / honourarium shall be paid to an editor/s whose compilation/editing work gets published in a book form by this University under any Grantha Series / :थमाला of this University.
9. The copyright of the **WORK** shall remain vested with the **PUBLISHER** i.e. Shree Somnath Sanskrit University on all editions.
10. The **PUBLISHER** shall deliver to the **A/E/R/T** free of charge, a total number of twenty (20) complimentary copies of the first edition on sharing basis in case of more number of **A/E/R/Ts** and two (2) copies each of successive editions of the **WORK** (on sharing basis in a case of more authors/editors/translators) when ready and the **A/E/R/T** shall have the right to purchase further copies for personal use, but not for sale, at 40% discount of the published price.
11. Neither royalty nor any honourarium shall be payable to the **A/E/R/T** in following matters:
 - i. On sale of the books by the **PUBLISHER**
 - ii. On destroying or selling off as waste paper any reminders of the old edition when a new edition is published.
 - iii. On the discarded or destroyed copiesIn the event of the **PUBLISHER** deciding to sell off the copies of the **WORK** as remainders, they shall give the **A/E/R/T** the first option to purchase such copies at the discount of 40% on all copies or editions of the **WORK** disposed off by the **PUBLISHER**. The **PUBLISHER** shall also have the right to scrap balance copies of the **WORK** in stock after three years of the date of re-sales of the **WORK**. In such an event, the **AUTHOR** shall be given the option to purchase any number of copies of the **WORK** at 40% discount of the published price.
12. In the event of any revised edition being required, the **PUBLISHER** shall, before publishing such editions make a written request to the **A/E/R/T** requiring him to bring the **WORK**-up-to-date, and

on such request being made he shall without undue delay, make the necessary revision free of charge.

13. If at any time the **WORK** goes out of print, the **A/E/R/T** proposes to the **PUBLISHER** to publish a new edition and the **PUBLISHER** do not publish the same within a period of two years, the **A/E/R/T** has the right to seek written permission from the **PUBLISHER** to publish his/her **WORK** independently.
14. The right and obligation under this Agreement belonging to and binding upon the **A/E/R/T** and the **PUBLISHER** respectively shall be binding upon the successors and assignees of administrators of the **A/E/R/T** and the **PUBLISHER** respectively.
15. In case, a publication grant is sanctioned by any agency towards the publication of the **WORK**, the **PUBLISHER** automatically becomes entitled to the full utilisation of the same. The **PUBLISHER** will have the liberty to receive such grants directly without permission from the **A/E/R/T**
16. If any dispute of difference relating to this Agreement arises between the parties hereto or any other each, or their umpire, in accordance with the provisions of the Arbitration Act of 1990, Veraval (Gir Somnath) Courts alone will have jurisdiction over all legal matters connected with this agreement.
17. A true copy of the Agreement shall be given to the **A/E/R/T** for record.
